ADVOCACY

- Unanimously passed amendments to the Illinois Credit Union Act to benefit credit unions of all asset sizes
- Implementation of a statewide Electronic Lien & Title System
- Initiated a rewrite of the proposed CRA Rule, making the final rule less burdensome for credit unions and providing more flexibility and time for implementation
- Led legislative efforts to oppose the Interchange Fee Prohibition Act and filed litigation challenging the constitutionality of the law
