What is CUPAC

The Credit Union Political Action Council (CUPAC) is a bipartisan, voluntary, non-profit, unincorporated organization of individuals, credit unions, chapters, and others. Its sole purpose is to promote good government and a favorable legislative climate for credit unions through raising and disbursing funds to political candidates, regardless of party affiliation, who are supportive of credit union issues.
